8. BUSINESS

A. Discussion and Possible Action: December 2019 Financial Report

Gabe Buldra, Principal for James Vincent Group, referred the board members to the December 2019 Financial Report in their packets. Mr. Buldra discussed the Key Points of the report, which included Revenues and Expenditures for the month of December. The fiscal year

expenses were \$5,383,064 which is under budget by \$122,361. Year to Date for Personnel costs are under budget by \$185,326.

Member Ed Lindquist moved to approve the financial reports for the month of December 2019 as presented, and Member Amy Kay seconded the motion. The vote was unanimous, and the motion carried.
