9. BUSINESS

A. Discussion and Possible Action: September 2022 Financial Reports

Gabe Buldra, Principal for James Vincent Group, presented the monthly financials for September 2022. He reviewed the key points which include the Revenue, Expenses and the Year-to-date Revenue and Expenses and Total Cash amount. The following were included in the board packet for review: Balance sheet as of September 30, 2022, Summary of Reconciled Cash Balances as of September 30, 2022, Income Statement of Revenues and Expenditures of General Fund for September 2022, including budget to actual and year-to-date balances, Capital Estimated vs. Actual expenses year-to-date, Income vs. Expenses graph for September 2022, Monthly Disbursement report, and 12-month cash flow. Mr. Buldra reviewed the Key Points for the monthly revenue and expenses and the year-to-date revenue and expenses. Revenue for the month of September is \$1,449,786 which is \$690,794 over budget, driven by tax collection. Navajo County revenue is \$928,962 which is over budget by \$598,593. Nonlevy revenue is \$520,823 which is over budget by \$92,200, driven by higher than anticipated Wildland and Ambulance revenues. Expenses for September total \$1,245,322 which is over budget by \$21,569. Personnel Costs are \$941,759 which is \$19,530 over budget, driven by higher than anticipated Wildland wages and associated benefit costs. Year-to-Date revenue is \$2,530,725 which is \$488,194 over budget. Navajo County revenue is \$605,329 over budget. Wildland revenue is \$204,940 under budget. Ambulance revenue is \$84,924 over budget. Year-to Date expense is \$3,830,726 which is \$198,283 under budget, primarily driven by lower personnel costs related to Wildland deployments and the associated benefit costs. Total cash for September is \$2,807,769, which is \$1,921,735 higher compared to September 2021. Referred the Board to the ambulance revenue breakdown graph. Member Jamie Adams asked about Prop 310. Discussion ensued with Mr. Buldra on how the District would budget the revenue.

Member Dennis Hughes moved that we approve the financial reports for the month of September 2022 as presented, and Member Paul Wyatt seconded the motion. The vote was unanimous, and the motion carried.

 - Chair Amy Kay said items B and C would be a discussion only with no action taken. Would be brought back as a future agenda item. Chief Russell gave the parcel number count and timeline for the public hearing. Discussion on future growth in the District. Chief Chevalier gave an update on the station response areas for Torreon and Porter Mountain Estates. City of Show Low is willing to work with the District for a location near Torreon. Trying to shore up the boundary lines with the District and CON.
